What is Serbia's energy strategy?

1.4.1 Serbia's current energy strategy is outlined in the 2005 Energy Sector Development Strategy and is being implemented through the 2007 and 2010 Implementation Plans. Further to this, the Energy Law anticipates the development of a new energy strategy for at least a fifteen year period.

What is the new Esco law in Serbia?

3.4.6 The new Law on Efficient Use of Energy¹³ (EE Law) has finally been adopted in Serbia and has become applicable as of 23 March 2013¹⁴. The Law explicitly defines an ESCO company and sets the rules for ESCO projects generally in line with the EU acquis¹⁵, and aims to provide the overall legal framework for energy efficiency arrangements.

Do foreign energy companies have to file for approval in Serbia?

Consequently, the relevant cases which arise are most frequently situations where the foreign energy companies have been subject to direct concentration outside of Serbia and, as a result of having subsidiaries in Serbia, have had an obligation to file for approval in Serbia as well¹². Renewables

Why is energy important in Serbia?

1.1.1 Energy is one of the largest sectors of the Serbian economy, accounting for more than 10% of Serbia's GDP. 1.1.2 The electricity market in Serbia is still dominated by state-owned public companies and is mainly characterised by the lack of full liberalisation, as well as the absence of significant participation by private companies.

The key changes to the Energy Law include the introduction of new market participants such as aggregators, warehouseers and active buyers.
